The club will hold an Open to Centre trial for solo machines only. To be held under the National Sporting Code rules of the ACU, the Standing Regulations for trials, these supplementary regulations and any final instructions which may be issued up until the start of the trial.

**Entry fees:** £20.00. Cheques payable to Leamington Victory MC&LCC. Must include 2 x SAE. Entries will close on the 2<sup>nd</sup> January 2017. Entries will be accepted up until 9:00am on the day of the trial at a cost of £25.00 but entrants will not be eligible for championship points. No trail or pre-65 bikes. Trial tyres only.

**Venue and Start Time:** Southam Rugby Club. Station Rd, Southam CV47 2DH. 1st rider away at 9:00am, the rest at one minute intervals. The method of marking for this trial will be TSR22B. Petrol is not available at the start.

**Course:** The trial will be of a sporting nature and will have 3 routes, and will include a 50-50 route, half the sections from the 'A' route and half the sections from the 'B' route. No trail or P-65 machines. All machines must have trial tyres.

**Note:** Events run as open trials. Any member of an ACU affiliated club can enter the trial.
